




• <u>White sugar</u> (23/3/2020 vs. 24/2/2020)

- May 20: 341.4 \$/t (17.7 %; 316.6 €/t)
- August 20: 332.5 \$/t (18.2 %; 308.4 €/t)
- <u>Raw sugar</u> (23/3/2020 vs. 24/2/2020)
 - March 20: 11.04 \$cts/lb (27.7 %; 225.0 €/t)
 - May 20: 10.90 \$cts/lb (26.0 %; 222.1 €/t)

White premium: around 98 \$/t on May/March basis (white/raw).














Differences between EU average price and regional average prices




EU market price for white sugar compared with World price London N°5 (first future - \$/t - €/t)

METHODOLOGY FOR THE ESTABLISHMENT OF SUGAR BEET PRICES

- The price shall be notified as follows:
 - one weighted average price per marketing year;
 - in national currency, per tonne;
 - taking account of all of the quantities purchased by sugar beet processors from beet growers in respect of the marketing year for which the price is notified;
 - converted to 16% equivalent sugar content.
- The total corresponding quantity of sugar beet shall be notified in tonnes.



EU Sugar Preferential Imports




Imports EPA / EBA in 2019/2020






Sugar TRQs 2019-2020 (20/3/2020)





EU Monthly sugar imports (CN 1701)









EU Total imports (2019/2020 – 4 m. - 0.741 m t)








EU Total exports

EU cumulated exports (CN 1701)





EU White sugar exports






EU Isoglucose

ISOGLUCOSE - EU monthly cumulated production for 2019/2020





Impact of Corona virus in the sugar market: Questions to delegates.



Impact of Corona virus in the sugar sector:

Some partial news about Coronavirus impact in the sugar sector (1).

- Czarnikow has updated downwards the world sugar consumption in a sugar balance this month mainly due to the collapse in out-of-home food and drink consumption, and the difficulties faced in operating normal supply chains.
- On the other hand sugar manufacturers like Suedzucker said on Wednesday last week that sugar supplies are secure despite heavy demand as some European consumers stockpile during the coronavirus crisis
- In the United Kingdom Associated British Food the owner or British Sugar confirmed on March 23 that *"in aggregate, we have not seen a material impact in our sugar, grocery, ingredients and agriculture businesses."*

Impact of Corona virus in the sugar sector:

Some partial news about Coronavirus impact in the sugar sector (2).

- In France, the sugar and ethanol company Tereos has decided to boost the production of pharmaceutical alcohol. Cristal Union redirects its production from bioethanol towards ethyl alcohol in one plant located in Arcis sur Aube.
- In Belgium La Raffinerie Tirlemontoise indicates an increase in sugar sales in small packages and also starts producing alcohol in BioWanze.
- As a partial conclusion it seems that in Europe sugar consumption is seen increasing via products that can be stored at home (sugar, biscuits, chocolates, ...) and decreasing via products usually consumed in bars and restaurants (soft drinks, ice creams...).
